1. You must own a Class A Membership Certificate to be a golfing member. New members may pay for their Class A Membership Certificate in one payment of \$400.00, or \$100.00 the first year and \$120.00 per year for three additional years (\$460.00 total payment). Class A Stock is refundable by New Ulm Country Club if membership is terminated.
2. Class B Membership Certificates are optional and cost \$500.00 each. Holders are entitled to a discount on their membership dues equal to \$30.00 for each Class B Membership Certificate owned.
3. Social members are required to own a Social Certificate which costs \$50.00 and includes their Social dues for one year.
4. By signing this application, you agree to:
  - a) Pay all monthly payments of your membership dues, if applicable.
  - b) Pay all four annual installments for your Class A Membership Certificate, if applicable.
  - c) Pay all charges on your account with the New Ulm Country Club by the due date or pay a monthly finance charge equal to 1.5%.
  - d) Abide by all rules of New Ulm Country Club.
5. By signing this Agreement, you agree upon default, to pay any and all damages incurred by the New Ulm County Club as a result of such breach, including but not limited to any unpaid obligation of membership, and including any and all costs of collection, including reasonable attorneys' fees.
